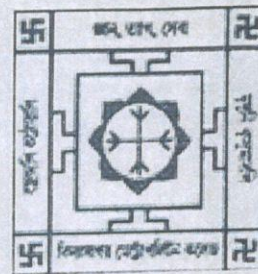






I. LEGAL FRAMEWORKS OF BOTH THE ORGANISATIONS:


Bhangar Mahavidyalaya, established in 1997 offering undergraduate courses and programmes to the students of diverse ethnic origins and multi-linguistic culture and affiliated to the University of Calcutta, represented by its **Principal, Dr. Virvikram Roy** hereinafter referred to as the FIRST PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns)


Vidyasagar Metropolitan College, established in 1961, and offering undergraduate courses and programmes to the students and affiliated to the University of Calcutta, and Government of West Bengal aided college, represented by its **Principal, Dr. Arghya Sarkar** hereinafter referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will be hereafter referred to as Parties.

II. PURPOSE OF THE AGREEMENT

Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions of higher education through following but not limited to:

1. Joint teaching-learning and internship
2. Collaboration in the area of research, publications, project work, etc.
3. Joint field trip, excursion, and education tour,
4. Joint training, add-on, certificate and vocational courses.
5. Joint extension activities, consultancy.
6. Joint faculty and staff development programmes.
7. Co-hosting and participation in conferences, seminars, symposia, and workshops, book fairs etc.
8. Sporting and cultural programs
9. Any other activity that is mutually agreed upon and is beneficial to both.
10. Collaborative programmes in Capacity building and skills enhancement initiatives like Soft skills, Language and communication skills,
11. Collaborative programmes in Life skills (Yoga, physical fitness, health and hygiene),
12. Collaborative programmes in ICT/computing skills,
13. Collaborative programmes in competitive examinations, career counselling, sports and cultural events,
14. Any other areas as may be mutually agreed upon.

III. TERM AND EXPIRATION OF THE AGREEMENT

This agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years it will be automatically extended for the same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination, or expiration, unless otherwise agreed upon between the Parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

IV. FREE TO EXIT:

Either of the parties would have the liberty to exit the agreement citing reasons for so if the linkage becomes untenable for any reason whatsoever.

V. NON-FINANCIAL IMPLICATION:


The linkage will not have any financial implication on either college.


VI. NON-EXCLUSIVITY:

3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.

If any dispute arises in respect of the MoU, in that case both the organisations will discuss and settle the matter amicably.




